CSCT ALBERTA DIRECTOR'S REPORT

ASRCT annual general meeting was held April 28, 2018 in Calgary. Elections were for two positions, CEU Coordinator and Education Assistant. Helena Xing remains the CEU Coordinator. Meghan Parise is our new Education Assistant as the elected member Judy Flannigan stepped down in August due to a move out of Alberta. Both positions are for 2-year terms.

Board appointed positions are Wendy Wilson, Registrar for a 2-year term. Cailey Dye, Provincial Director with provincial duties only for a 1-year term to mentor with Mary Fielden. Sherry Raven, Treasurer for a 2-year term or until a new suitable candidate steps forward with interest in the position. Other Board positions remain the same.

We had diverse speakers presenting on Women's Cardiac Health, Gun's & Gang Violence and the Fentanyl crisis and Effects of Legalized Marijuana on Healthcare workers. Helena Xing our CEU Coordinator attended a conference and shared an EP studies presentation. Lyndsay Arndt from the Alberta College of Combined Lab and X-ray Technologists (ACCLXT) gave a Health Professions Act (HPA) application update. There was a good Q&A and we are on track for our portion that the Alberta government needs completed. Recent news from the College however, tells us no new professional legislation amendments are on the fall government docket as was expected and we are now in a "holding pattern" for regulation. The government's focus has shifted to amending a key piece of legislation in the HPA itself. This set back is disappointing, but we remain hopeful for the future and will continue to work closely with the College to move forward in the step by step legislative process.

Four students from Alberta wrote the September 2018 CSCT Certification Examination and we welcome all successful to be ASRCT members.

Our sincere appreciation goes to the CSCT 2018 CCC/AGM organizing committee for all the hard work preparing and planning educational events and the AGM. All our members benefit because of the efforts of these dedicated volunteers.
