EDUCATION AND EXAMINATION REPORT 2010-2011

In April 2010, 70 candidates wrote the CSCT certification exam and 44 were successful. In addition, 33 candidates rewrote the theory portion and 15 rewrote the interactive portion.

In September 2010, 95 candidates wrote the certification exam and 57 were successful, 32 rewrote P1 theory and 13 rewrote P2 interactive portion.

20 CSCT members have written the ETT post certification exams. This was the final time the ETT post certification was available for first time attempts. Once unsuccessful candidates have reached the max number of attempts allowed, the ETT CDs will be made available to the general membership and to CSCT approved Cardiology Technology school programs.

The CSCT certification exam rewrite policy was revised to clearly word the number of attempts as the exam is limited to 4. Following the April 2010 exam, 3 candidates will not have access to the exam until they have successfully graduated from a CSCT approved/CMA accredited program as new students.

The software of the theory portion of the certification exam was upgraded to a user friendly interface. The theory practice exam was revised to match the exam blueprint based on the 2007 CSCT National Occupational Competency Profile (NOCP) and was put on the CSCT website in March 2010.

The Interactive portion of the certification exam is in the process of upgrading to make it available online, thus eliminating CDs being shipped and copied on to servers at the exam sites. This will make the multimedia interface run more smoothly.

The CSCT is developing a new national membership database that will encompass exam candidates and results, enabling each province and the exam committee to keep more accurate information on candidates and our membership.

Among the big items for Education and Exam committees is revalidation of the 2007 NOCP. It is critical that the NOCP is kept up to date as it has to reflect the work done by Cardiology Technologists in the field today, and introduce

competencies that will become important in the future. This process was started by the provinces asking their members for any skill areas they would like considered for inclusion, revision or those which are obsolete and can be deleted. Gretchen Dunn and Shauna Ryall have put together an action plan for CSCT to revalidation of the 2007 NOCP.

The Exam Committee has been busy creating new questions for the Certification Exam. The Exam Committee and the Provincial Education Coordinators (PEC) are in the process of compiling a list of reference textbooks and material to assist candidates in preparation for the CSCT National Certification Examination. The Exam Committee expects to have this list available for June 2011.

Mandatory CSCT CEUs second trimester deadline was December 2010. The CSCT is grateful for the assistance of the provincial associations and members for complying with the policy. The CEUs demonstrate our members commitment to their profession and for excellence in patient care. The Theory and Interactive practice exam are accessible to ALL CSCT members (go to www.csct.ca click on the student side and then "links to the exam") and is a valid instrument for obtaining CEUs. Check with your province as to the CEU value of the exam. Remember this is the start of the new triennium. This triennium ends December 2013 and failure to obtain 30 CEUs will result in having to write a reinstatement exam.

CSCT would like to congratulate Stenberg College in BC in obtaining a 6 year accreditation with the Canadian

Medical Association and to Mohawk College in Ontario in obtaining a 2 year accreditation. They now join the Campbellton College CCNB (French program) in completing the accreditation process. Stenberg College is also in the process of developing a hybrid program that will run outside the BC lower mainland. The other cardiology technology programs i.e. British Columbia Institute of Technology (BC), Everest College (ON) and CAT Centre of Arts and Technology (NB) are at various stages in the accreditation process.

The CSCT Education Day held at the Canadian Cardiovascular Congress in Montreal this past October was well attended and was a great success. After the opening remarks our first speaker Brenda Robinson from Calgary, AB. gave a presentation on "Diversity", The second presenter was Dr. Jan Kornder. His topic was "Janus View of ACS Care" and the third speaker was Stephen Mundle and his presentation was on "Do we just get in shape or is there more?". The Education sessions were very interesting, informative and stimulating.

I would like to announce CSCT's new Assistant Education Director, Sara-Jayne Cameron, from New Brunswick. She will work with the Education Director and assume my position in October 2012.

On behalf of the Exam Chair, Provincial Education Coordinators and the Board of Directors I would like to extend my heartiest gratitude to the outgoing Education Director Gretchen Dunn. Gretchen passionately helped organize the policy manuals, hand guides and policies for our Board. The volunteer hours she spent ensuring that CSCT maintains a high standard for examinations and education will not be forgotten. We appreciate her dedication and commitment to the Society.

Gretchen will still assist us as a resource person on education and

CSCT CEU Non-Compliance Policy

Past CSCT CEU triennium - Jan 1 2008 to Dec 31 2010.

Members who have not completed and submitted their 30 CEUs post marked on or before December 31, 2010 will be fined \$150 by their province.

Non-compliant members should have completed and submitted all required CEUs post marked on or before March 1, 2011. If they have not, they will have to write and pass a reinstatement exam in September 2011 (see the exam hand guide in the member area of www.csct.ca for more information)

If any member has a question regarding the above policy, please contact your Provincial Director or Provincial Education Coordinator.

REGISTRAR'S REPORT


Hello again Fellow Members,

Understand a Proxy

It seems that there is some confusion and misunderstanding regarding the Proxy that comes with your notice of meeting. This article will hopefully provide some insight, and help everyone better understand what a proxy is all about.

The Merriam-Webster Dictionary defines proxy as:

- (1) Authority or power to act for another;
- (2) A document giving such authority;
- (3) A person authorized to act for another

A Proxy (more correctly called an 'Instrument of Proxy') enables someone to vote on matters at a meeting without being present. You give your vote to someone to exercise for you. On the Proxy form, there is a place for you to write in who you would like to 'carry' your vote for you. The next few lines indicate the matters that will be voted on. You may vote yes (for) or no (against) to these motions. If you leave it blank, the person whose name you have filled in will vote for you. In the matters that come up in meetings, the person carrying your Proxy, whom you have designated, will vote on your behalf. As you do not know what the issue is about, you are placing your trust in the person holding your proxy.

Of course, there are exceptions. On issues outline on the Proxy (called Proxy Issues), the person holding your Proxy must vote in the manner you have indicated. This ensures that you are able to have your say on matters that are known before the meeting. The bottom area of the proxy must also be filled in with the date and your name, signature and numbers. If you have forgotten your numbers, they will be filled in for you. Each proxy is scrutinized by the Registrar to make sure it is correct.
